International conference "Kant and the Ethics of Enlightenment. Historical Roots and Contemporary Relevance" (Immanuel Kant Baltic Federal University in Kaliningrad, April 22-24). The conference will also be joined by prof. Gordon, who will be giving a talk titled "Kant and Applied Ethics: The Concept of Personhood under Fire".

Research Project: SIENNA

Recently, prof. John-Stewart Gordon has been invited to contribute to the SIENNA project as one of the selected experts. Focused on the ethical, social, and human rights aspects of AI, the SIENNA project is holding a workshop at Uppsala University (Sweden) this June in which prof. Gordon will be expected to engage in discussions with around 20 other leading scholars in the fields of AI and ethics.

Keynote Speech

On the 20th of February, prof. Jonas Ruskus gave a keynote speech at a conference on inclusion, participation, and human rights organized by Humboldt University (Germany). In his speech, titled "The Human Rights Standards for a Full Social Inclusion of Persons with Disabilities: The UN Perspective", he introduced the new UN Convention on the rights of persons with disabilities, which heralds a new epoch of how such persons are treated in the world by shifting the paradigms from charity and medical model to the social and human rights model of disability.

Published Textbook: Professional Ethics of Lawyers

This February, a textbook on ethics for professional lawyers co-authored by the staff of VMU's law faculty was published. Among the authors and editors are prof. Edita Gruodyte, dr. Paulius Astromskis, and prof. Julija Kirsienė who is also a part of the "Future Law, Ethics, and Smart Technologies" project. The textbook, titled "Professional Ethics of Lawyers", is the first of its kind in Lithuania and is aimed at improving both the theoretical knowledge and the practical skills of future lawyers.
